3. Supervising the Board of Management by the Board of Directors

- The Board of Directors (BODs) has overseen the operations of the Board of Management (BOM), management personnel of the Corporation through regular and irregular meetings of BODs, monthly business meetings of the Corporation and its Subsidiaries, meetings and work sessions with its Subsidiaries, and the established reporting structures (encompassing financial reports, production and business reports, inspection, monitoring, and evaluation of the production and business efficiency of the Parent Company and its Subsidiaries).
- The Board of Directors has conducted meetings, both in-person and online, regarding specific topics, projects, critical tasks, and other matters deemed necessary by the Board with Authorized Persons of the Corporation, subsidiaries, invested companies, and joint ventures, to provide timely direction on matters within their purview, ensuring all activities throughout the Corporation comply with the law, resolutions of the General Meeting of Shareholders, and resolutions of BODs. The BODs also implemented the 2024 Supervisory Program to 03 Subsidiaries (PTSC M&C, PVShipyard, and PTSC Thanh Hoa).
- The Board of Directors has directed and developed the Action Program to implement the 2024 tasks of the Corporation, disseminating it to all departments, staff, and workers; being decisively and promptly carrying out the key tasks and proposed solutions; being focusing resources to enhance operations, progress, investment capital disbursement, and investment portfolio management, promoting the Corporation's key investment projects. Efforts are being made to address difficulties and obstacles in processing investment procedures, ensuring project timelines are met as planned, and conducting investment activities effectively and sustainably. Additionally, timely measures are being taken to resolve challenges faced by the Corporation and its Subsidiaries to mobilize all resources for the development of production and business operations.
- The Board of Directors has directed BOMs to closely monitor global, regional, and domestic developments, including policy adjustments by major economies and related countries, particularly in monetary, fiscal, trade, and investment policies; enhancing its

analytical and forecasting capabilities to proactively respond in a timely manner and flexibly and effectively manage fluctuations. Priority is given to addressing challenges and obstacles arising from changes impacting the Corporation & its Subsidiaries' business activities. Emphasis is placed on solutions to promote investment, manage the investment portfolio, and intensively focus on key investment in 2024, towards priority areas of PTSC's production and business development, ensuring a rational and effective investment structure.

- The Board of Directors has directed BOMs to continue implementing the Project/Plan for restructuring the Corporation through 2025 in a manner that is effective and aligned with the actual conditions of its business activities; developing PTSC's Development Strategy up to 2030, with a vision to 2050, and the Five-Year Plan for the 2026–2030 period in line with PVN's Development Strategy. Additionally, the Corporation has finalized the Digital Transformation Strategy and continues to advance communication efforts and corporate culture integration in its management, production, and business operations.
- In addition, to enhance effective support tools for supervision work, the Board of Directors has decisively directed the review, revision, and new issuance of the internal management regulations and rules of the Corporation, to update in accordance with state regulations, the Enterprise Law, the Securities Law..., work requirements, activities, management practices, corporate governance, and the production & business situation of the Corporation.

4. Activities of the Board of Directors' subcommittees (If any):

- Based on the assignment of members of the Board of Directors, each Member of the BODs is assigned specific tasks related to the functions of the Subcommittees according to their fields and specific work, and the Members provide opinions on each content when the BODs needs to review and decide on matters within its authority.
- In April 2024, the Board of Directors approved the 2024 Internal Audit Plan based on the review of the proposal from the Head of Internal Audit of the Corporation, for the Internal Audit Department to implement and carry out internal audit work in 2024, in compliance with the Internal Audit Regulations, related regulations on internal audit, and current regulations.
- The Secretary Division of the Corporation is responsible for assisting the Board of Directors with key functions such as advising on corporate governance, managing and handling the work of the General Secretary, assisting the BODs and the Supervisory Board, developing plans, organizing the General Shareholders' Meeting in compliance with current legal regulations, managing relations with shareholders, investors, and the public (IR), and overseeing internal control of the BODs..

5. Resolutions/Decisions of the Board of Directors

- In 2024, the Board of Directors organized 5 meetings and issued 77 opinion polls (including 12 confidential polls); a total of 320 documents were issued (including 39 confidential documents), among which there were 140 Resolutions and Decisions (including 14 confidential Resolutions and Decisions) related to business production issues, investment, personnel organization, staff, personnel planning, and other tasks... The list of Resolutions and Decisions (excluding confidential Resolutions and Decisions) issued by the Board of Directors is stated in Appendix 01 of this Report.

3. Supervising Board of Directors, Board of Management and shareholders by Board of Supervisors

Based on the rights and responsibilities of the Board of Supervisors (BOS) according to the provisions of the Enterprise Law, the Charter of the Corporation, the operational Regulations of the BOS, and the implementation of the inspection and supervision Plan for 2024, the BOS has carried out the inspection and supervision of the organization of PTSC's production and business activities and financial management in 2024 according to the following contents.

- Conducting the evaluation of the Financial Statements, Reports on production and business activities, and Reports assessing the management work of the Board of Directors in 2024, preparing the Report to submit to the 2024 Annual General Meeting of Shareholders.
- Supervising compliance with legal regulations, PTSC's Charter, the implementation of regulations, resolutions, and decisions of the annual and extraordinary General Shareholders' Meeting and the Board of Directors.
- Supervising and monitoring the situation of implementing production and business activities; the situation of implementation, progress, and effectiveness of investment projects, bidding, and procurement of the Corporation.
- Evaluating the quarterly and annual Financial Statements. Assessing operational efficiency and debt repayment capability, management and use of capital, and preservation and development of equity capital.
- Monitoring capital balancing and cash flow management; oversee capital mobilization and utilization, and evaluate the effectiveness of capital use by the Corporation.
 - Monitoring the implementation of the Corporation's Restructuring Project.
- Evaluating the performance of the internal audit system and propose recommendations (when applicable) to enhance the effectiveness of the internal audit system.
- Monitoring and evaluating transactions between the parent Corporation, Subsidiaries, and companies controlled by the parent Corporation with over 50% of Charter Capital and members of the Board of Directors, General Director, other executives of the parent company, and related parties; evaluating transactions between the parent company and companies where members of the Board of Directors, General Director, or other executives of the parent company are founding members or managers within the last 3 years prior to the transaction.
- Coordinating with state regulatory agencies, inspection teams, internal audits of major shareholders, and the parent company in monitoring and supervising the management work and business operations at the unit, overseeing the implementation of recommendations in the reports of inspection and audit teams.
- Implementing other tasks of the BOS as requested by the General Meeting of Shareholders and current regulations..

Through the inspection and supervision tasks in 2024, the BOS found that the management and operation of the Corporation by the Board of Directors, General Director, and the management apparatus of the Corporation comply with state laws and PTSC's Charter. The resolutions, decisions, and directives of the Board of Directors comply with

the provisions of PTSC's Charter and the General Meeting of Shareholders and have been implemented by the General Director as required.

4. The coordination among the Board of Supervisors, Audit Committee, the Board of Management, Board of Directors and other managers

The Board of Supervisors coordinates closely with the Board of Directors and the General Director in carrying out its functions and duties as prescribed. The Board of Directors and the General Director have facilitated the BOS in performing its tasks, providing all necessary information and documents related to the activities of the Corporation; the BOS is invited to attend all meetings of the Board of Directors, business and other meetings of the Corporation.

Reports summarizing the inspection and supervision tasks regarding management, administration, capital management and usage, payment capacity, internal control, bookkeeping, and quarterly financial reporting by the Supervisory Board are sent to the Board of Directors and the General Director.

5. Other activities of the Board of Supervisors (if any):

The Board of Supervisors has carried out the supervision of compliance with regulations, resolutions, decisions, directives, and internal audit reports of the Parent Company - Vietnam Oil and Gas Group related to the management and business operations of the Corporation; coordinating with the Board of Directors and the General Director in managing the Capital of the Corporation invested in other enterprises.
